**Who is a Purchaser?** This Limited Warranty is only applicable to Products sold to the first Purchaser and used in the applications described below within the United States. Under this Limited Warranty, a Purchaser means any of the following: (1) a person who purchases and installs the Product in a dwelling that is owned and used by that person as a primary or secondary home; or (2) any person or business such as a builder, contractor, or developer that purchases and installs the Product in a newly constructed or remodeled dwelling that will be used by the initial owner/purchaser of that dwelling as a primary or secondary home (in such situation, this Limited Warranty may be assigned to the initial owner/purchaser who is a Residential Purchaser (as defined below) who uses the dwelling as a primary or secondary home). Under this Limited Warranty, a primary or secondary home does not include rental property. Purchaser includes "**Commercial Purchasers**" and "**Residential Purchasers**." Commercial Purchasers include, but are not limited to, Purchasers who are landlords, leasing companies, contractors, remodelers, and private and public businesses that purchase and/or install the Product in a dwelling that will be leased, used as a rental unit, or used for any other commercial or industrial use. Commercial Purchasers may not assign or transfer this Limited Warranty. Residential Purchasers mean all Purchasers other than Commercial Purchasers. Except as allowed by applicable law, Residential Purchasers may not assign or transfer this Limited Warranty.

**What Does This Limited Warranty Cover?** Subject to the exclusions and limitations set forth in this Limited Warranty, MFS Supply warrants to You that each Product will be free from defects in material and craftsmanship, under normal use and maintenance, for the applicable warranty period stated above; provided that You purchased the Products from MFS Supply or the onestock® Amazon Store. This Limited Warranty does not extend to Products purchased from unauthorized sellers and is only applicable to Products used in residential applications within the United States. This Limited Warranty will terminate if You no longer meet the requirements of a Purchaser under this Limited Warranty.

**How Long Does the Warranty Period Last?** The applicable warranty period for Your Product begins on the date that the Product was delivered, [whether, in the case of a Residential Purchaser, purchased by You or by a third party on Your behalf,] and lasts for the period detailed in the coverage chart above. For Residential Purchasers, the applicable warranty period terminates if You sell or otherwise transfer Your Product. If You are a Residential Purchaser, Your warranty is only valid if You use the dwelling as Your primary or secondary home and does not extend to future owners if the property is sold.

**Sole and Exclusive Remedy:** In the event of a defect in the craftsmanship or materials of a Product occurring during the applicable warranty period described above, at MFS Supply's sole option, MFS Supply will repair or replace the defective Product, or, if it is not commercially feasible to repair or replace a defective Product, refund the original purchase price of the defective Product or provide credit toward a similar type of Product sold by MFS Supply. The foregoing are Your sole and exclusive remedies for any Product defect or non-conformity. By way of example but not limitation, the following costs and expenses are not covered by this Limited Warranty: (1) labor costs incurred by You or Your permitted assigns under the terms of this Limited Warranty for the original installation, removal, or reinstallation of the Product; and (2) labor costs incurred by You or Your permitted assigns under the terms of this Limited Warranty or material charges for the removal, reinstallation, repainting, refinishing, or replacement of any other items or building materials which must be removed, replaced, reinstalled, or refinished in order to repair or replace the defective Product.



The repair or replacement remedies offered by MFS Supply under this Limited Warranty are contingent on the current Product offerings of styles and construction options within MFS Supply's Product line at the time a warranty claim is made by You. If a valid warranty claim is filed prior to expiration of the applicable warranty period for an obsolete Product, MFS Supply reserves the right, at its sole option, to honor its repair or replacement obligations under this Limited Warranty by either: (1) replacing the affected Product with a new Product of the same or approximate style or color from MFS Supply's current Product line or offerings; or (2) replacing the affected Product to achieve a uniform appearance with a similar or comparable Product style or approximate color of the originally purchased style. If a Product is replaced or repaired, MFS Supply cannot guarantee an exact match with the finish or appearance of other products or fixtures installed at Your dwelling.

**What Does This Limited Warranty Not Cover?** This Limited Warranty does not apply to any Product which has been subject to (1) use for purposes for which it is not designed or intended by MFS Supply; (2) misuse, vandalism, abuse, negligence, accident, alterations, or unauthorized modifications; (3) improper storage (if the Product must be stored, it should be covered and stored in a humidity- and temperature-controlled environment away from direct sunlight); (4) improper installation, cleaning, or maintenance; (5) improper temperature, moisture and/or humidity extremes (temperature outside the range of 50–85°F (10–29°C) and humidity outside the range of 30–55% are considered extreme); (6) natural disaster, acts of God, or other external causes beyond MFS Supply's control; (7) sunlight, smoke, or other environmental conditions which have caused variances in color and characteristics; (8) use of abrasive cleaners, cleaners that contain chlorine, acidic cleaners, scuffing sponges, or steel wool which have caused effects on the color and/or integrity of the finish or appearance; (9) corrosive air; or (10) outdoor installation or use. Products may experience changes in appearance due to normal wear and tear. Normal wear and tear is not a defect and is not covered by this Limited Warranty. This Limited Warranty does not cover any damages or expenses caused by any defective Product.

**How Do You Obtain Warranty Service?** In order to be eligible for service under this Limited Warranty You MUST: (1) contact MFS Supply in writing during the applicable warranty period at the address below specifying the defect and requesting instructions on how to proceed; (2) provide MFS Supply with any requested additional information; and (3) return the Product to MFS Supply within thirty (30) days after being instructed to do so by MFS Supply, along with a description of the defect and documentation of being the original Purchaser.

**Residential Purchaser Rights under State and Other Law:** This Limited Warranty gives Residential Purchasers specific legal rights, and Residential Purchasers may also have other rights which vary from state to state in the United States.

**Disclaimer of Other Warranties:** CERTAIN OTHER STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE BELOW LIMITATION MAY NOT APPLY TO YOU.

THIS LIMITED WARRANTY IS MFS SUPPLY'S SOLE AND EXCLUSIVE WARRANTY WITH RESPECT TO THE PRODUCTS. ALL IMPLIED WARRANTIES ARE STRICTLY LIMITED TO THE DURATION OF THE LIMITED WARRANTY APPLICABLE TO THE PRODUCT AS STATED ABOVE, INCLUDING BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY, NON-INFRINGEMENT OF PROPRIETARY OR THIRD-PARTY RIGHTS, OR OF FITNESS FOR A PARTICULAR PURPOSE. EXCEPT AS SET FORTH ABOVE, MFS SUPPLY MAKES NO OTHER WARRANTIES AND HEREBY DISCLAIMS ALL EXPRESS OR IMPLIED REPRESENTATIONS OR



WARRANTIES REGARDING THE PRODUCTS. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF.

**Limitation of Liability:** Certain other states do not allow the exclusion or limitation of incidental or consequential damages, so the below limitation or exclusion may not apply to You.

The remedies described above are Your sole and exclusive remedies and MFS Supply's entire liability for any breach of this Limited Warranty. MFS Supply's total liability shall under no circumstances exceed the actual amount paid by You for the defective Product. Further, MFS Supply shall not under any circumstances be liable for any consequential, indirect, incidental, special, or punitive damages or losses (including lost profits), even if this Limited Warranty is deemed to have failed of its essential purpose.
